The Food

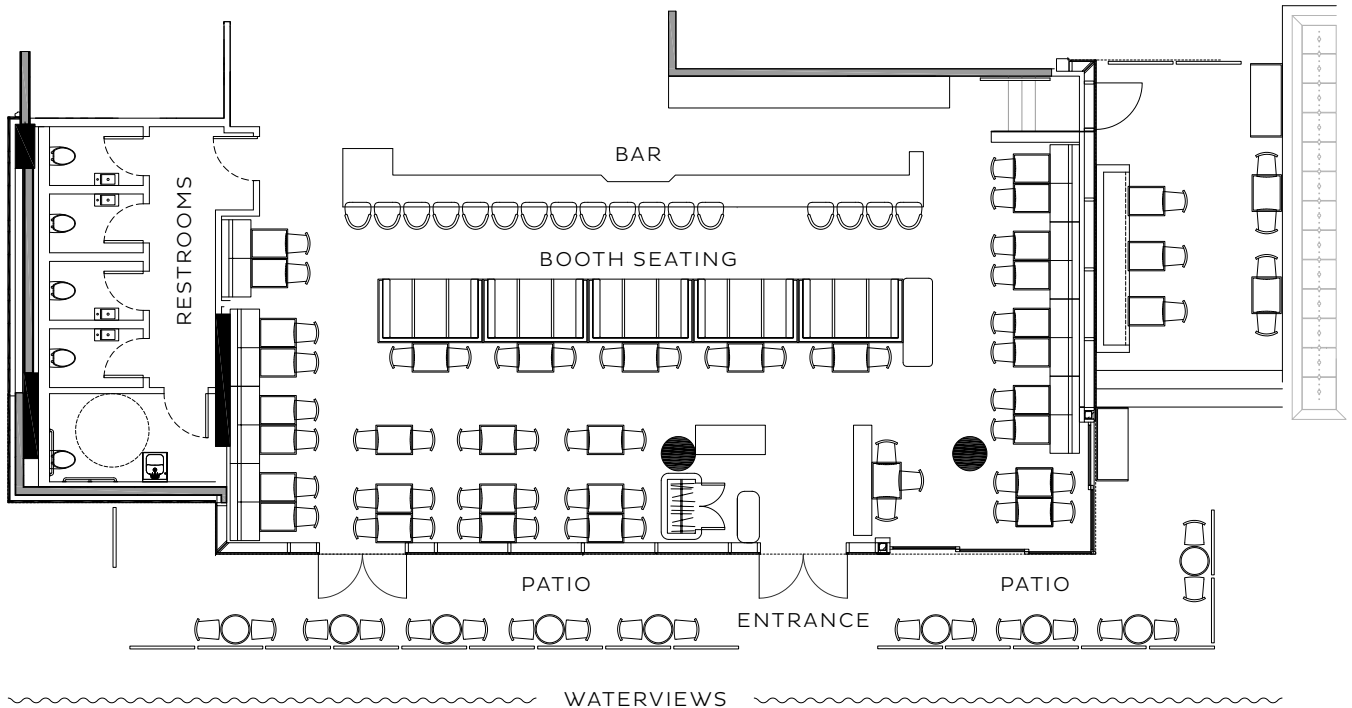

Seated Style - up to 90 guests

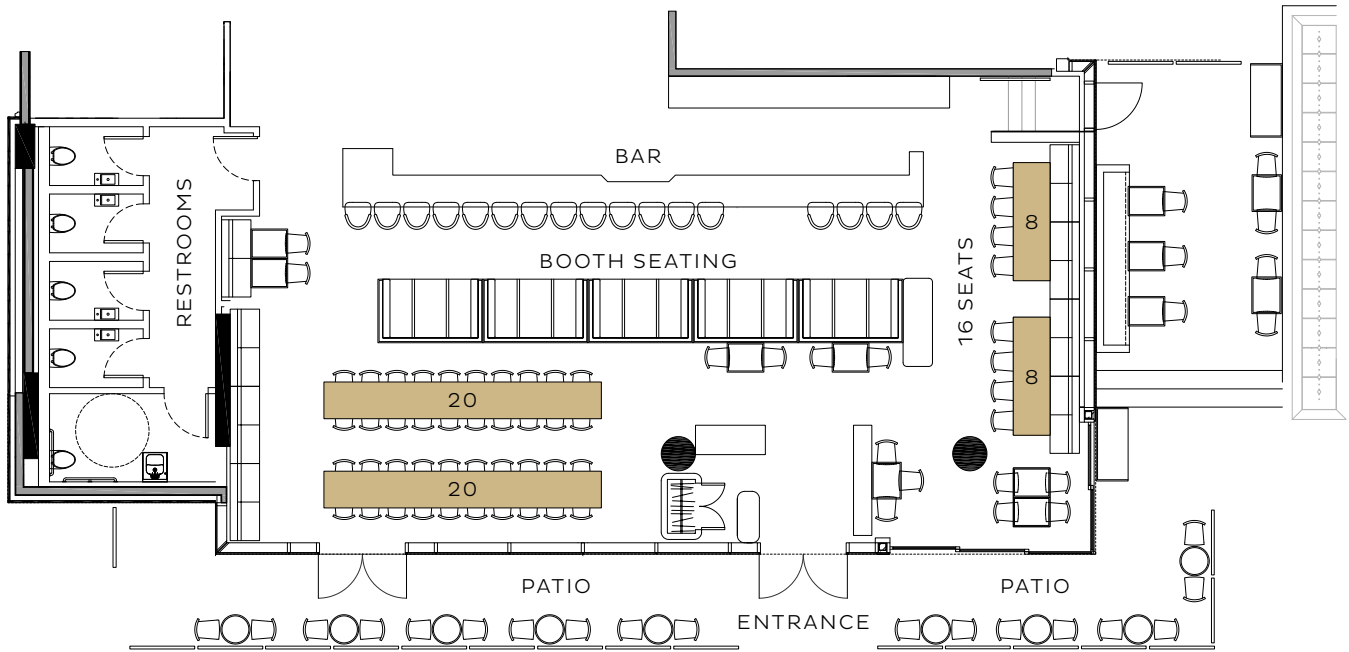


Floorplans are not to scale and layouts can alter slightly.

Ceremony Layout

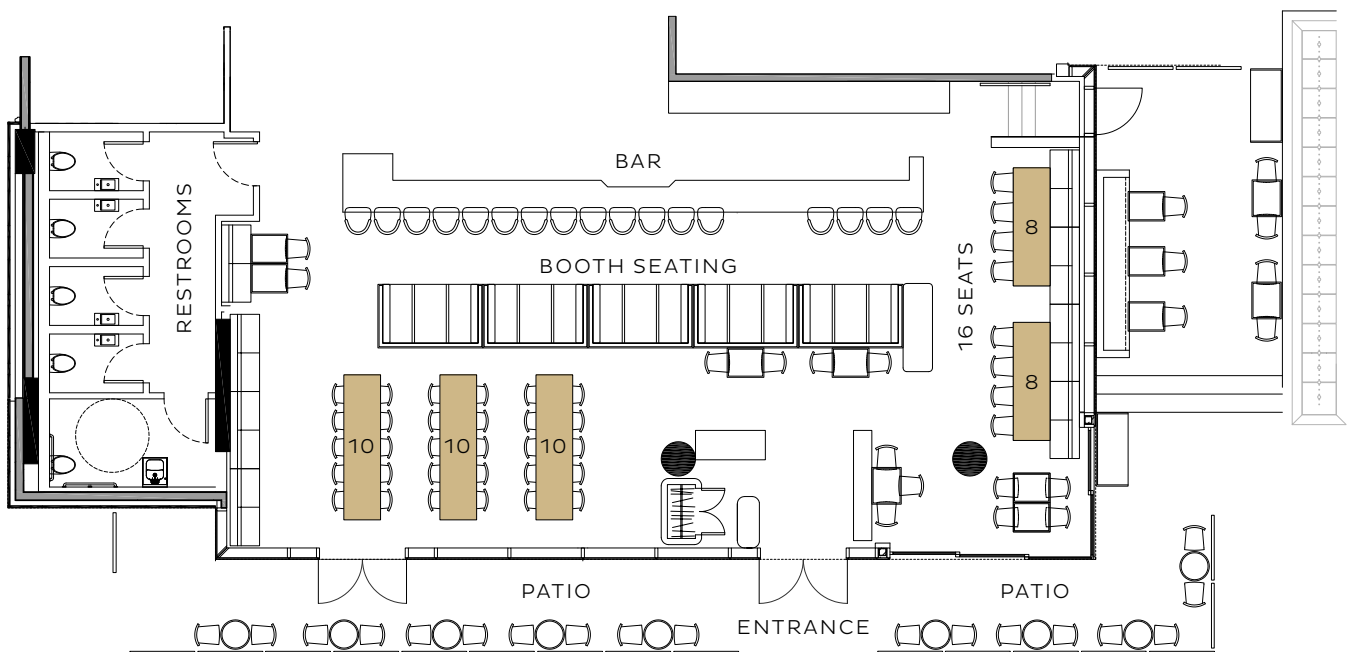
FULL VENUE BUY-OUT

Terms & Conditions

CONFIRMATION, DEPOSITS & PAYMENTS

A signed contract, deposit, and valid credit card number are required to secure a booking. Without a paid deposit, Ancora Waterfront Dining and Patio reserves the right to release the space to other guests.

All group reservations are confirmed upon receipt of a 25% deposit of the minimum spend. Deposits are non-refundable. Groups seated in the main dining room require a \$20 deposit per person.

The full bill must be paid on the event date and may be applied to the credit card on file. Ancora Waterfront Dining and Patio is unable to bill guests after the event date.

Ancora Waterfront Dining and Patio accepts cash, credit card, and corporate cheques. Personal cheques are not accepted. All food and beverage orders must be purchased on one bill.

The restaurant reserves the right to host more than one function on the property at any time.

PRIVATE DINING & MINIMUM SPENDS

Reservations requiring exclusive use of a portion of the restaurant or the entire space are subject to a minimum food and beverage spend, as outlined in the event contract. Minimum spends are determined by the date, time, and space booked, and do not include applicable taxes or gratuity.

CANCELLATION POLICY

Cancellations made within 14 days of the event will be charged 50% of the event minimum spend, in addition to the non-refundable deposit.

Cancellations made within 7 days of the event will be charged 100% of the event minimum spend, in addition to the non-refundable deposit.

In the event of a no-show, the restaurant reserves the right to charge the full minimum spend, plus applicable tax and gratuity.

The signature on the event contract authorizes Ancora Waterfront Dining and Patio to charge any cancellation or no-show fees to the listed credit card.

All cancellations must be submitted in writing by email to the Event Contact. Cancellations made within 24 hours of the event date must also be accompanied by a phone call.

GROUP DINING MENUS

Parties of 10 or more are required to select a group dining menu.

Menu selections and final guest count must be submitted to the Event Contact 7 days prior to the event. After this deadline, no further requests or accommodations will be honoured.

All menu items and prices are subject to change. Guests will be notified of any changes as soon as possible.

GUARANTEED NUMBERS

A guaranteed minimum number of guests is required 10 business days prior to the event date. We will not accept a range, such as 50-70 guests, for the final guest count.

If this number decreases with less than 72 hours' notice, the agreed-upon menu price will be applied to the number of guests specified on the contract.

GRATUITY

All group bookings are subject to a 20% automatic gratuity.

DÉCOR

Guests are welcome to personalize their event with custom décor. Items may not be nailed or glued to the walls, and confetti is not permitted. The space must be returned to its original condition. Charges may apply for any damages.

LIQUOR LAWS & PERMITS

Alcohol service ends at 12:00 am. The patio closes at 10:00 pm. Event hosts are responsible for their guests' conduct and any damages incurred to the property, equipment, or employees of the restaurant. Ancora Waterfront Dining and Patio reserves the right to discontinue service to any guest.

Dancing is not permitted unless a special event permit is obtained. Ancora Waterfront Dining and Patio may apply for this permit on behalf of the client, and the cost will be billed to the client. The client must inform the restaurant at least two months in advance.

Ancora Waterfront Dining and Patio is not responsible for any lost or stolen property during the event.
