Since opening our doors in the summer of 2015, Ancora has received numerous awards and accolades. This legendary waterfront location is truly a window to Vancouver, and its culinary scene.

Ancora's dining space was designed with soft modern lines that embrace the warmth and richness of the city's waterfront landscape. The interiors feature a subtle mix of soft blues, sand-inspired neutrals and light woods to thoughtfully reflect a gentle, coastal feel, and a serene but sophisticated style.

Gorgeous fishnet-inspired crystal chandeliers were imported from Italy, along with custom-colour premium leather furniture sourced from Europe. The back feature wall in the lower dining room was enhanced with soft gold wall tiles that mimic the ocean's waves. The bar, a mainstay of the room, was finished with rich walnut, faced with a unique, wood-mosaic tile, and topped with gorgeous onyx.

Lighting underneath further highlights the beauty of the natural veining of the stone incorporated into the bar. Not to be forgotten, the private dining room brings an ambiance of upscale elegance that's ideal for small parties or private get-together.

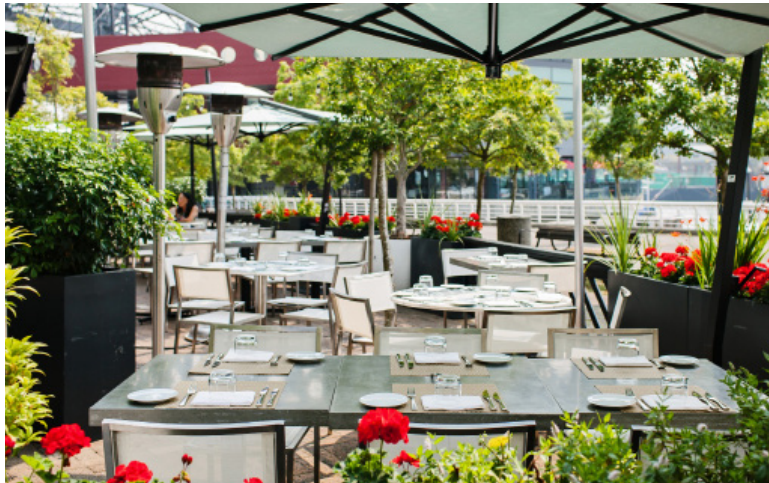

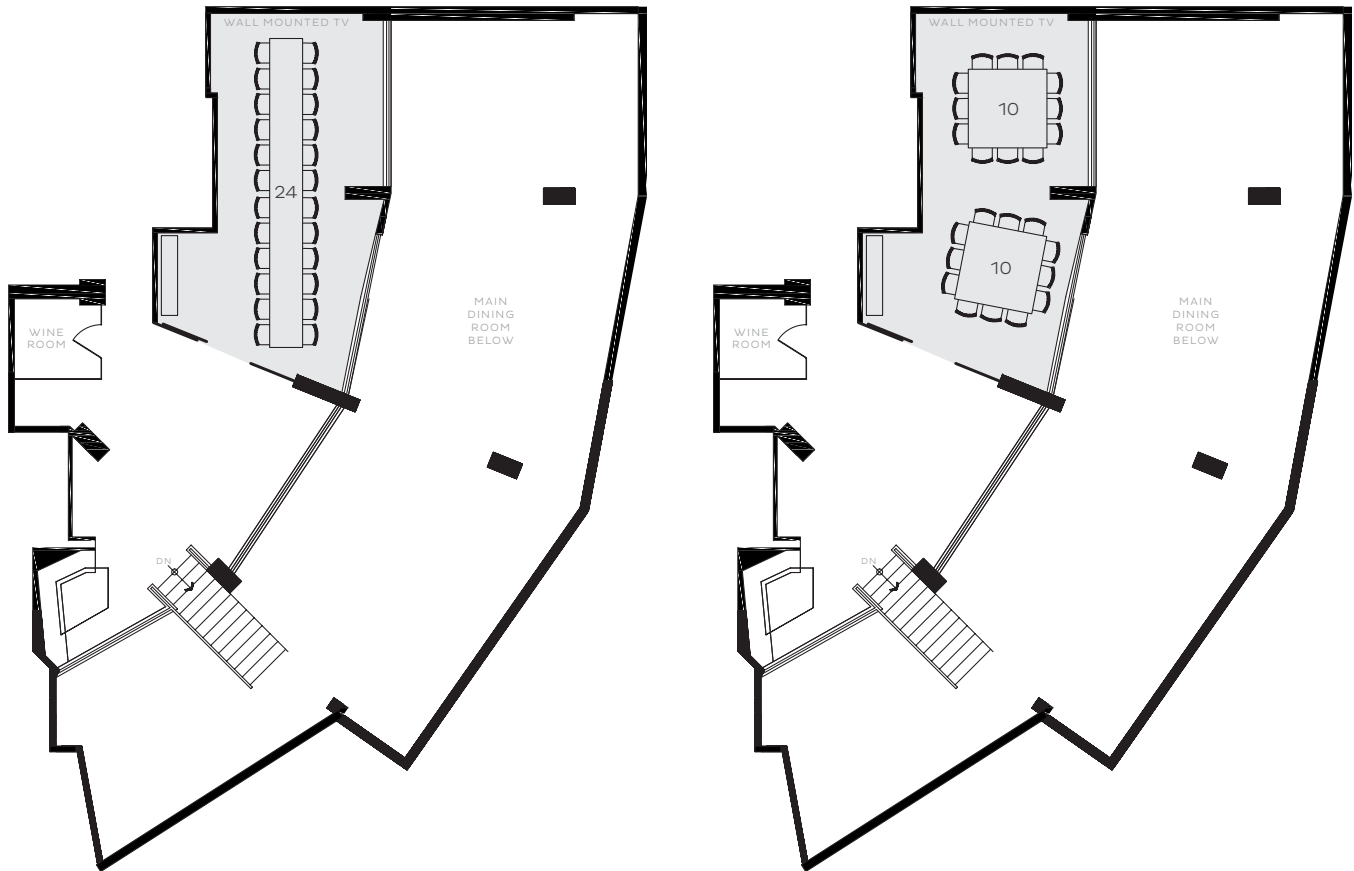

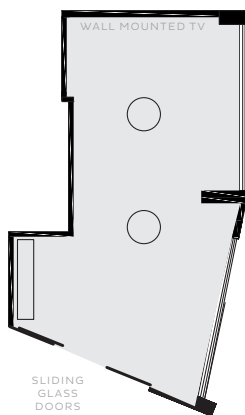

Reception Style - 35 guests max.

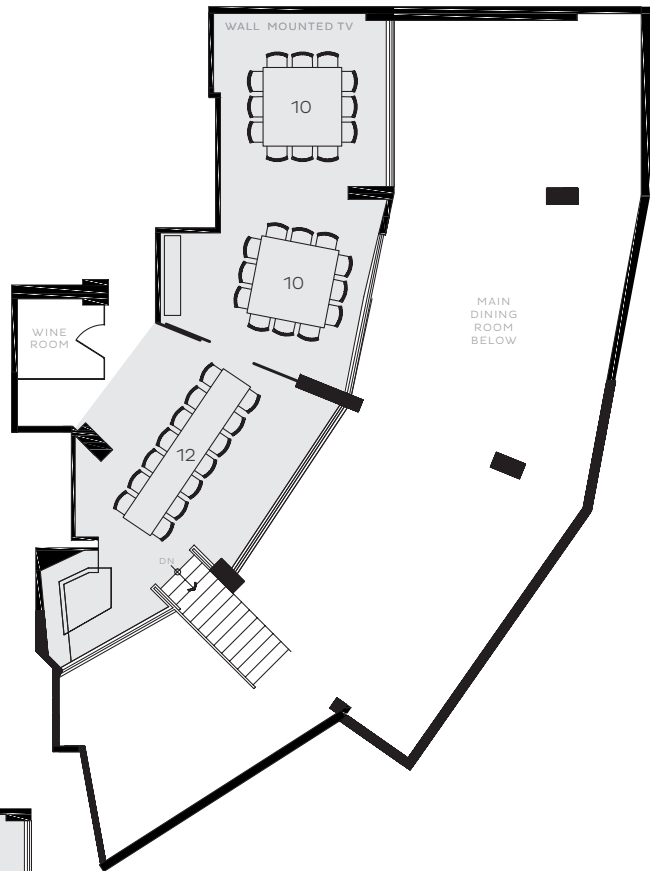
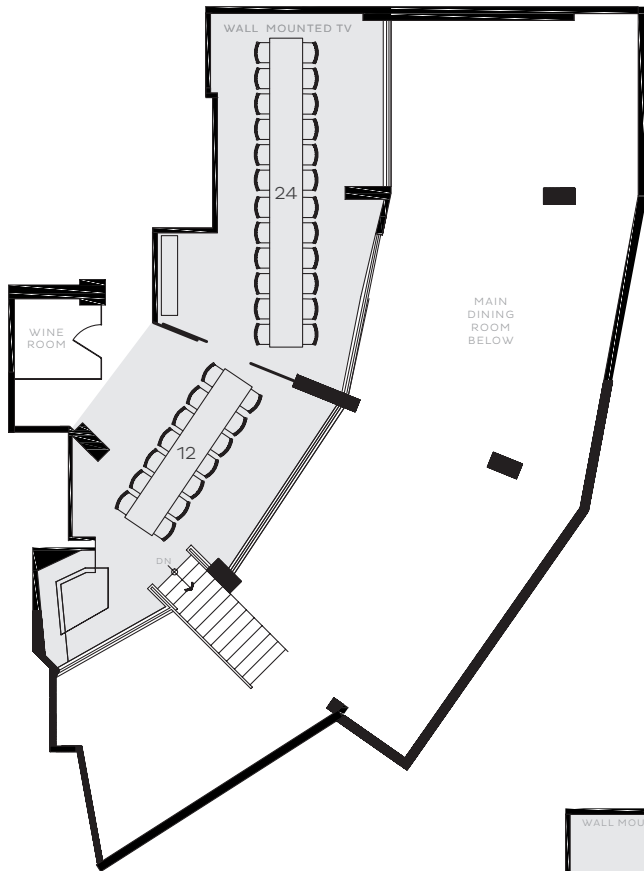


FLOORPLANS ARE NOT TO SCALE AND LAYOUTS CAN ALTER SLIGHTLY.

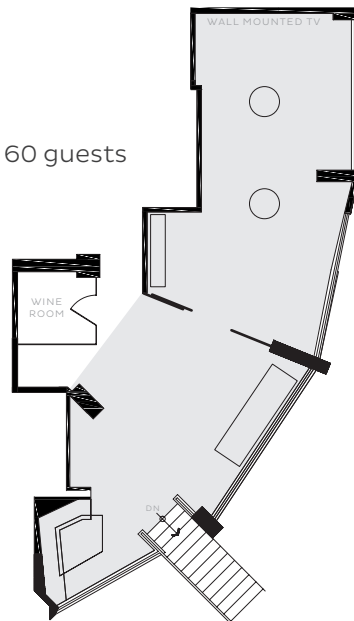

Reception Style - up to 60 guests



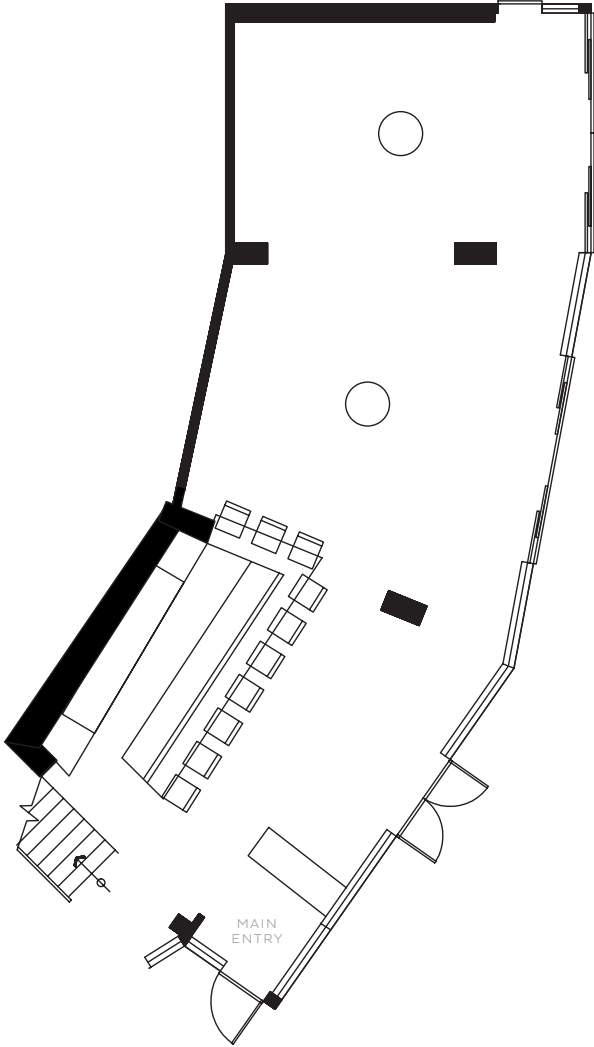
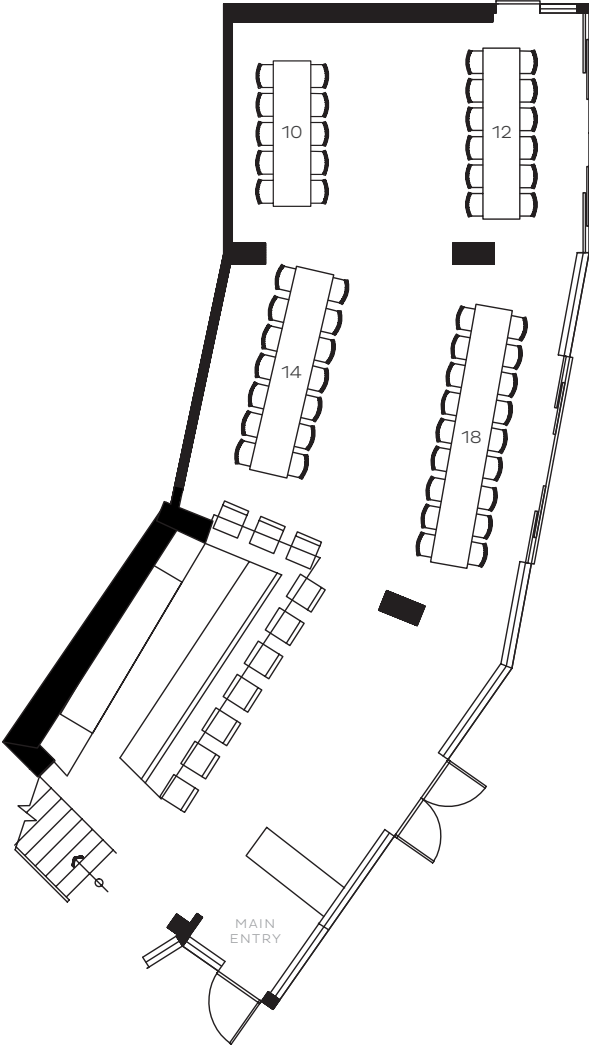
FLOOR PLANS ARE NOT TO SCALE AND LAYOUTS CAN ALTER SLIGHTLY.

Reception Style - up to 110 guests

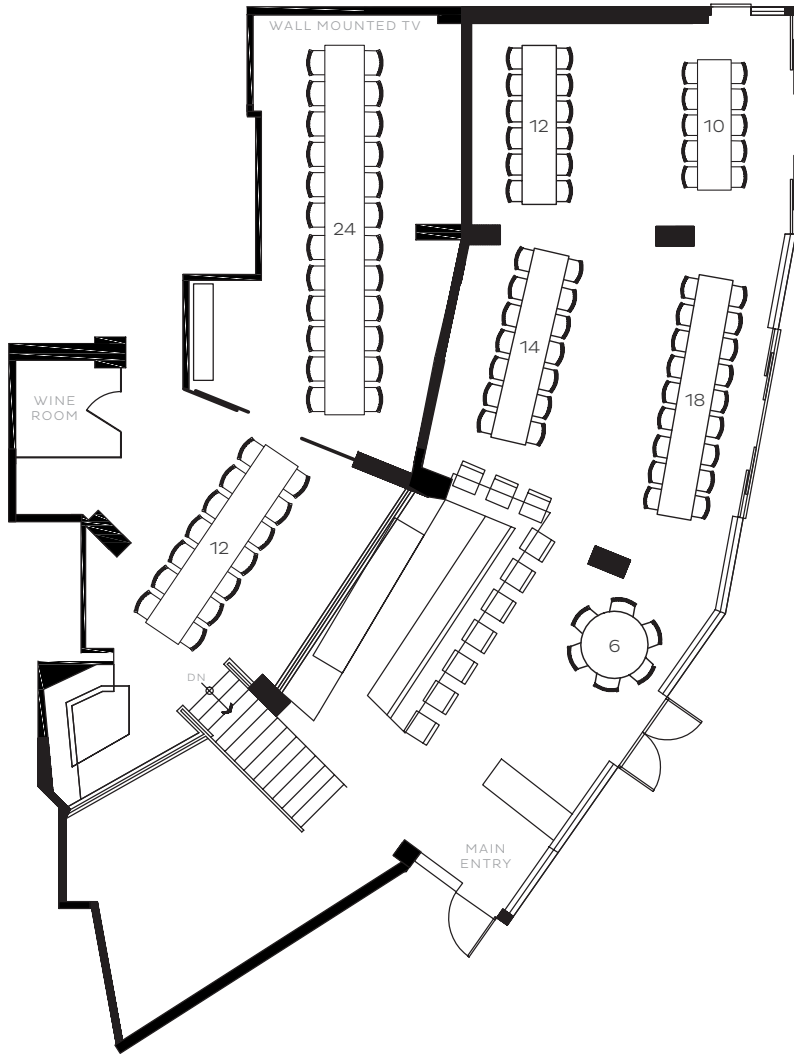


FLOOR PLANS ARE NOT TO SCALE AND LAYOUTS CAN ALTER SLIGHTLY.

Seated Style – 96 guests

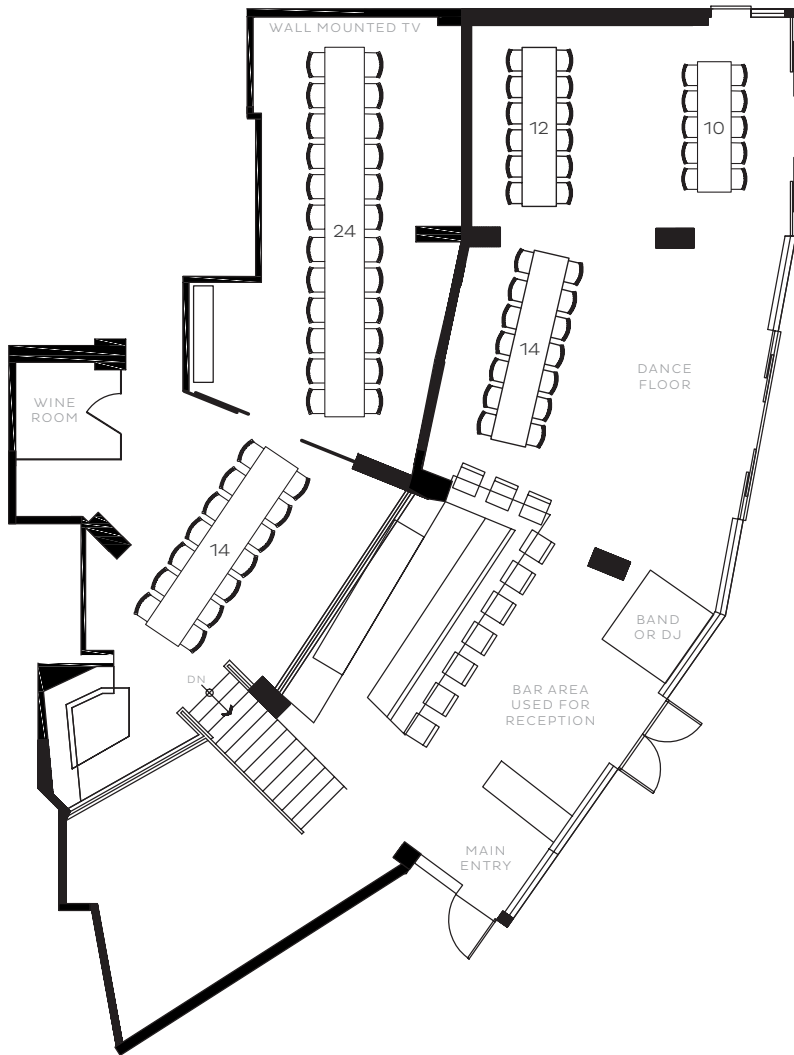


FLOOR PLANS ARE NOT TO SCALE AND LAYOUTS CAN ALTER SLIGHTLY.

Terms & Conditions

CONTRACT

A signed contract and non-refundable deposit with a valid credit card number is required in order to secure a booking. If a deposit is not received within 48 hours of booking, we reserve the right to release the space to other guests. The entire bill must be paid in full on the event date, and can be applied to the credit card on file. We are unable to bill guests after the event date.

The restaurant reserves the right to hold more than one function on the property at any time.

CANCELLATIONS

A 25% charge of the non-refundable deposit will apply to cancellations made within 30 days. Cancellations within 14 days will be charged 50% of the overall event minimum spend, in addition to the non-refundable deposit. Cancellations are only accepted by contacting the Event Contact directly. All cancellations must be in writing by email to the Event Contact. All cancellations over email within 24 hours of the event date must be accompanied by a phone call. The signature on the event contract authorizes Ancora Waterfront Dining and Patio to charge any necessary fees to the listed credit card should a cancellation of such nature occur.

Cancellations with less than 14 days notice will be charged 50% of the deposit, less than seven days 100% will be charged of the deposit. All deposits are non-refundable.

MINIMUM SPENDS

All parties are required to meet the minimum food and beverage spend as outlined in their event contract, which is determined by the date, time and space booked.

Note: the minimum spend does not include applicable taxes and gratuity.

FOOD & BEVERAGE

All menu items and prices are subject to change (guests will be notified of these changes immediately). A 20% pre-tax gratuity will be applied to all group menu bookings.

BILLING ARRANGEMENTS

Ancora Waterfront Dining and Patio accepts cash, credit card and corporate cheques for payment. We are unable to accept personal cheques. All food and beverage orders must be purchased on one bill.

DÉCOR

Guests are welcome to personalize their event with custom décor. We kindly ask that items not be nailed or glued to the walls to prevent damage. No confetti.

LIQUOR LAWS

Provincial liquor regulations set out by the B.C. government prohibit the service of alcohol after 11:59 pm. Event hosts are responsible for the orderly conduct of their guests, as well as any damages incurred to the property, equipment or employees of the restaurant. We reserve the right to discontinue service to any and all guests.

Ancora Waterfront Dining and Patio is not responsible for any lost or stolen property during the event.

CONFIRMATION OF BOOKING

This form must be completed and returned with a signature in order to secure your group's reservation.

PRIVATE DINING

Reservations requiring exclusive use of a portion of the restaurant or entire space will be subject to a minimum spend based on the date and time of the event.

DEPOSITS AND PAYMENTS

All group reservations are confirmed upon receipt of a 25% deposit of the minimum spend. Without a deposit we reserve the right to release the space. Deposits are non-refundable.

CANCELLATION POLICY

Cancellations within 14 days will be charged 50% of the minimum spend. Cancellations within 7 days will be charged 100% of minimum spend. In the event of a no-show, the restaurant reserves the right to charge the entire minimum spend, including tax and gratuity. The signature on the event contract authorizes Ancora Waterfront Dining and Patio to charge any necessary fees to the listed credit card should a cancellation of such a nature occur. All cancellations must be in writing by email to the Event Contact. All cancellations over email within 24 hours of the event date must be accompanied by a phone call

Parties of 10 or more are required to select a group dining menu. Menu selections and final guest count must be submitted to the Event Contact 7 days in advance of the event, after which no further requests or accommodations will be honoured.

GUARANTEED NUMBERS

A guaranteed minimum number of guests is required within 10 business days prior to the event date. If this number decreases with less than 72 hours' notice prior to the event, the agreed upon menu price will be applied to the number of guests specified on the contract. We will not accept a range (i.e. 50-70) for the number of guests.

Ancora Waterfront Dining and Patio is not responsible for any lost or stolen property during the event.
